Firewise Volunteer Clearing Crew News

The Firewise Clearing Crew has returned to work again. We are assisting our Community Association with the ice storm clean up by clearing the downed debris and preparing it for removal from the Level 3 areas. N12 found us preparing a large amount of downed limbs, as well as helping with some drainage control in this area. In N36, we had double duty while clearing this Level 3 area near the golf course we had to make sure that no stray golf balls were heading in our direction. The Crew definitely enjoys their work days. Look around the exterior of your homes and see what you can do to help keep our community a "Firewise Safe" community.

The First Five Feet

The Firewise concept is based on critical zones around the preimeter of the house. The most important is the 0-5 feet zone next to the house. The zone is known as the immediate or noncombustible zone. The goal is to reduce the potential for embers landing near the house to ignite dry fuels exposing the house to flames.

Shrubs can be a hazard if dry material builds up under them. The hazard can be reduced by maintaining a 6-12 inch clearance from the wall and a 4 -6 inch clearance above the mulch. Some shrubs may not by easily maintained and more care is needed to reduce the dry material under them.

Exposed wood is another concern. Examples are door frames (including garage) and posts would be areas of concern. Keep these areas clear of accumulated leaves and other dry material.
