Landscape Supervisor, Carlton Mathis reported that Level 3 mowing has been completed, and they are now starting the second round of Level 3 mowing as grasses and brush in the first neighborhoods done are already high enough to be of concern. They are also working on removing trees downed from the freeze earlier this year.

EMC liaison, Brian Richard reported that the EMC approved the Emergency Operating Procedures and assume that Firewise is in the process of accomplishing its operations as approved. EMC is working on organizing flu shot clinics, and will have table at the Town Hall.

Wildfires, Embers and Houses, A Good Mix? Firewise Town Hall, October 5, 2021, SCB 9:30 am

So its raining this week? Over at least the last 6 weeks, Sun City has had well below average rainfall. There have also been a number of small vegetation fires around Georgetown. Remember, we are always 6 weeks of low rainfall from a dry period.

What will October give us? Join the Sun City Texas Firewise Group on Tuesday, October 5 at 9:30 AM in the Social Center Ball Room, for our Town Hall. Research and documentation have shown that embers from a nearby wildfire are the major contributor to home fires that occur during a wildfire event. We will discuss and use videos to review the information.

Is your home prepared for embers from a nearby wildfire? Knowing where your Sun City home is vulnerable, what is around it, and other factors can assist you in taking actions that reduce the possibility of your home burning.

Join us as we present information about wild-fires, wildfire behavior, and how a wildfire could affect your Sun City home. Using this information will give you things you can do now to reduce the potential for embers to ignite your home.

Texas A&M Forest Service and the Georgetown Fire Department will have presentations. Emergency Management Committee, COPs, Property & Grounds Committee, and Wildlife Management Committee plan to be available with information and answer questions.

REMEMBER: It could be too late for action once a wildfire threatens.
