## New Tree Pruning Guidelines



New tree pruning guidelines have been developed for Sun City. Based on information from Texas A&M Forest Service and others, our trees have a very low probability to ignite from falling embers. Pruning in the future should be done to prevent damage to the roof and walls of the house. A clearance of 4-6 feet above the roof when possible and is adequate and should provide 2-3 years before pruning again. For walls, 3-5 feet clearance is desirable although that may not always be possible.

We have requested our trained tree companies follow the American National Standards Institute (ANSI) A300 Standard.
