Carlton Mathis is the person to contact for that area. An article regarding this is planned for May issue of Sun Rays. There have been 1037 requests, 989 of those have been completed and 48 remain open.

Renewal Work Group:

At previous meetings, Paul Ohlenbusch reported that annual Renewal documentation was completed on time and was submitted to NFPA. We have received our approved renewal certificate, which covers us for 2021.

Firewise Clearing Crew:

Petra Garren reported that the clearing in N47 is complete and residents there are very thankful for removal of a lot of willow and debris. There are 5 areas to review for future work which Petra will do with Glen. Petra reported she has about 50 volunteers, of which about half are regular participants.

Other Topics:

Dick Bruneau and others stated that the operating procedures are from 2011 EMC and need to be updated. EMC needs to approve. They are online and can be downloaded.
