<u> Another Hint for N48 Homeowners</u>

Trouble with Smoke/Carbon Monoxide (CO) Detectors

Recently, at 11:00pm, I experienced my smoke/carbon monoxide (CO) detectors chirping. I spent over an hour trying to silence them so we could sleep. I tried blowing them out with compressed air, I changed the batteries--they still chirped. I did not know there is actually a code to the chirping. Later, I found it was: one chirp occurring approximately once a minute means **Low Battery**/change the battery; three chirps occurring approximately once a minute means **Malfunction Signal**/detector needs to be replaced; and five chirps occurring approximately once a minute is the **End-of-Life Signal** (immediately replace the detector). My detectors were giving me the three chirp signals that the detectors needed replacement. But I did not have new detectors on hand. My only option to get some sleep was to remove the detectors from the ceiling and place them outside the house. Even disconnected (with the batteries removed) the detector units will still chirp for some time until the internal charge is discharged over time.

All our homes are equipped with smoke/CO detectors which will have problems as they age. The manufacturers generally warranty them for ten years to the original retail purchaser and this warranty is not transferrable. The oldest homes in our N48 neighborhood had units installed in the fall of 2014 and are now eight years old. Many of these units are starting to fail. I personally have replaced the smoke/CO detectors in

two homes in the past month and I have spoken with a friend who has helped replace detectors in three homes lately.

These detectors seem to start chirping at the most inconvenient times; usually in the middle of the night. In my case it was at approximately 11:00 PM and we had four international guests in the house trying to sleep!

The National Fire Protection Association (NFPA) recommends that our homes be protected with Smoke/CO detectors as follows: one unit outside each sleeping area and one unit inside every bedroom. Additionally, in homes of "new construction" these units must be supplied with alternating current (AC)/commercial electrical power (the batteries in our units are only a back-up source of power).

Our units are additionally hard wired, which means these units have both commercial power to the unit (while they also have a 9-volt battery as back-up). They also are interconnected with all the other detectors in the home. When one smoke alarm functions due to detection of smoke or carbon monoxide (or when they chirp for tests, low battery or malfunction) all units will alarm or chirp. When one unit fails, toward the end of its life, it will chirp its signal followed by the same signal from other units in the house. This feature makes it difficult to determine which unit needs replacement while the others, which are just as old, may still be functional.

Because it is hard to determine which unit has failed, it is recommended that residents of N48 who have homes that are approaching the end of these detector units' useful life, do one of two things: replace smoke/CO detectors all at one time, or purchase enough detectors to replace all units but replace them one-at-a time (if you think you can determine which unit has malfunctioned).

It is my recommendation that you replace these units when they fail with the very same model you currently have. The detector's model number and date of manufacture is printed on the backside of the unit. The current units have mounting collars attached to the ceiling and the units just require a half twist to let the detector loose and then the unit must be unplugged from the ceiling. Detectors of a different manufacturer may require that a different mounting collar or wiring system be installed, which could complicate the detectors' replacement.

There are several sources of replacement detector units: on-line vendors, Home Depot (but their on-line site stated the model number I needed was no longer carried), and the local Ace Hardware carries the model we have in our homes.
