Ron was not in attendance, however he sent a message through David continuing his warning about the danger of snakes, scorpions, and spiders and to watch for them when we go through junk in the garage or debris and mulch in the garden. He also warned that folks are seeing centipedes including the Texas red-headed centipede which can measure 5 to 7 inches long (Carlton said he saw one recently almost a foot long). They can inject venom with some huge pinchers. Unless you have an allergic reaction, the bite is like a bee sting with localized swelling and pain that subsides in hours. So be careful and be aware!
