Treasurer Ramona reviewed the financial statement and moved that it be approved as presented. There was no discussion. Kathy Davis seconded the motion which passed.

# Vice President's Report

Vice President Maria Tolleson reminded members that we shall be hearing about every aspect of WHO's participation in the Holiday Day Meals event at the next general meeting.

Maria introduced Jamie Tanner, founder of Simple Sparrow Care Farm. Jamie explained that the care farm addresses the growing field of "traumathology" - how trauma effects a person's mind and body. Simple Sparrow was her hobby farm to start. Through the gardens, land, and animals, she learned how to better nurture her own children about caring for themselves and others. After observing its effect on Jamie and her family, a friend suggested that the farm be used to help other traumatized members of the community. She began to explore how to use animals beyond horses for this purpose. She demonstrated a method for observing reactions by presenting a snake and a rabbit to the membership.

Jamie was asked how she manages client referrals. She explained that mental health professionals learn how to use the care farm and provide their own clients. Trauma is the basis of each case.

Maria presented Jamie with a check for \$500 to be used in their general fund. Jamie graciously accepted the check and thanked WHO members for their generosity.

Maria introduced WHO member Carrie Marshall and Sheryl Coy, founders of Good Neighbor GTX. Carrie explained the purpose of the newly founded non-profit. This non-profit exists to support children of low-income and in-crisis families in the Georgetown, TX area. They do this by providing the basic necessities of clothing and essential living items FREE of charge. For more information, visit their website gngtxinfo@gmail.com. Members were very supportive and excited about this new non-profit.

Maria informed members that the speakers for 2024 would be attending the January 2024 meeting.

# **Old and New Business**

Pat Schuerer, organizer of the toiletries drive for the Holiday Meals event, reminded everyone of what was needed – shampoo, toothpaste and toothbrushes, and deodorant.
