### **December 2023 Financials & FY23 Roll-UP**

**December 23:**Dec income totaled \$0.00. As common practice, all membership income for the month of Dec was deferred by CA accounting to the following fiscal year. Expenses of \$1,604.50 included: Court Reserve \$231, Arlo \$10.64, player development \$464.36, court activities \$211, Admin \$158.45 and final costs of the Holiday Gala of \$529.05.

**FY23 Roll-Up:**Revenues for FY23 totaled \$44,350.50; with \$24,112.50 coming from membership dues and the remaining from Special Events ticket sales and charitable fundraising. Expenses totaled \$44,184.73; of that \$17,742.15 was Special Events related, \$5,000 for Charitable Contributions, and the remaining for routine club operations, player development and member relations. We ended the FY with a net income of \$165.77 and a cash balance of \$6,638.72.

## FROM OUR PICKLEBALL FRIEND

This month's column is all about the rules and a question that I'd like to ask you concerning the changes implemented last August around Rule 4.9.B.

*"4.B.9. The referee will confirm and correct, if necessary, that all players are in the correct position and the correct server has the ball before calling the score.* 

4.B.9.a. If the referee or a player stops a rally in progress to correctly identify a player/position error, the rally shall be replayed. If a player stops a rally and incorrectly identifies a player/position error, it is a fault on the player who stopped the rally. If the referee stops a rally

*in progress and incorrectly identifies a player/position error, the rally shall be replayed.* 4.B.9.b. If a player/position error is identified after the rally has played out, the rally shall stand."

The submission title for this rule was: *"Correct Pro Player Positions Before the Serve"*. Some of the arguments for the rule were:

"This is the first of what is expected to be a limited number of rules specific to the pro and senior pro game. "And, "This eliminates, or at least minimizes the need for pro players asking repeatedly, 'Are we good?' on broadcast or livestream TV. Feedback from broadcast executives has been overwhelmingly negative on how this impacts the broadcast and the sport as a professional enterprise. "Most of the comments submitted concerning this change were negative. You can look at the details as well as all the comments here...<u>https://rules.usapickleball.org/entry/1017/</u>

So, what happened? Why was this change made? Well, here are the comments from the Rules Committee and from the Board (which is the final authority).

The USAP Rules Committee voted against this rule saying:

"This rule has been in effect for 16 years and is one that make the sport unique. The existing remedy of simply asking the referee for confirmation (i.e., Am I good) may occur frequently but is overwhelmingly handled quickly and smoothly with no adverse affect on the flow of the game. Regardless, these faults are relatively infrequent. It may seem unfortunate that a

game can end on this type of fault, but it is no different than ending a game on an NVZ or a service foot fault. There are few, if any, other sports where the referee coaches players to avoid a fault. This is not a large enough problem to warrant elimination of a long-standing, fundamental rule. Just because it may be easy for a referee to do does not justify removing responsibility from the players to comply with the rule."

The USAP Board, however, voted to approve the rule change reasoning:

"The majority of the Board feels that faults resulting from not keeping the accurate score or remembering correct positions should not determine the outcome of a pickleball match."

Final thoughts: As it's currently written, it appears that this rule only applies to games where there is a referee (4.B.9.). However, the 'incorrect position' sections in 4.M. and 4.N. (Server and Receiver Faults) have been deleted. This means that these types of faults no longer apply in any game. Will there be even more changes? Maybe we'll see when the 2024 Rulebook is published in January. I'll let you know if there are as soon as I can.

So, back to my question to you: What do you think about this new rule and how will we apply it here at Sun City in the interim?

#### This Month's Rules Questions from our members

**Q:**A player volleys a ball just short of the Non-volley Zone (NVZ). Although his momentum is about to carry him into the NVZ, he fights it for a while but finally falls in the NVZ. Meanwhile the other players keep hitting the ball and it is hit 3 or more times before he eventually falls into the NVZ. Did he commit a NVZ fault?

**A:**Yes, that would be a NVZ fault. Here's the rule...

"9.C.1. It is a fault even if the ball becomes dead before the player contacts

the non-volley zone."

One of the unique things about NVZ faults it that it is the only fault that can be committed after the ball is 'dead', and there is no time (or subsequent shot limit) on when the fault actually occurs if momentum from the shot carries a player into the NVZ.



## PICKLEBALL FRIEND (cont.)

**Q:**If a serve hits the centerline is it good or not?

**A:**Good question. I often ask this as a trivia question..."What are the dimensions of the service court?"The answer is, 15' x 10' 1". That's because the center line, like the side and base lines (but not the NVZ line) are 'In' on the serve. See Rules 3.A.37. & 4.A.2.

#### There is a lot of NEW in this NEW YEAR.

#### First --THE PLAYER DEVELOPMENT TEAM LOVES CMARS

It's 2024 and lots of things are happening. First, we are transitioning all of our member training programs to CMARS. For many of you that doesn't mean a thing. But for those members who are looking forward to taking training classes it means all of our registration will now be done in CMARS. OK, don't panic!, for the month of January we will be asking you to register for classes using CMARS but for the Introduction to Pickleball and Beginner Training Classes, we will also allow you to register through email as we have in the past.

Second, our Pro Clinics are back and will consist of 2-4 clinics per month for all skill levels. More information can be found in the Ongoing Program Update below.

Third, Beginner Training classes are being scheduled in both the original 5-day format but also in a 3-day format (Tuesday – Thursday) and a 3 consecutive Saturday format. More information can be found in the Ongoing Program Update below.

**Supervised Novice Play (SNP):** We graduated 208 students from SNP in 2023, bringing our total to 747 graduates since the program's inception in August 2020.

**Skills and Drills (S&D):** The Spring Skills and Drills classes will be offered beginning on 5 March 2024. Registration on CMARS will be available on 1 February at 5:00 pm. In the meantime, if you have taken some of the classes, find someone who was not able to and become their drill partner.

**Advanced Pickleball Strategy (APS):** The first APS class of 2024 is scheduled for 16 January 2024. In addition, February classes will be offered on 6 and 20 February 2024. Registration will be through CMARS and will open 14 days prior to each scheduled class at 5:00 pm.



#### Train the Trainer Classes.

We completed our second 2023 Train the Trainer class in December. As a result we were able to add 19 new members to the Player Development Team

Canceling play that day


